Dear all,

First, on behalf of all EUMS I would like thank the EC Vaccines Team, and in particular 5.1.2e for securing a fantastic expanded access plan for the vaccine from Pfizer/BioNtech.

To recap: we have a 200mio contract for Initial Doses (that are already being delivered) and agreed a few days ago the allocation for 2x50mio Optional Doses. (This was a complicated process and has some impact on the Top Up doses – see below). Whereas it would have been nice to re-open all that to simplify things, I take it that most people agree with 5.1.2e statement that the "the first

two cakes are done" (200+100).

So what I attach is a first Bazaar table for the new 200mio, of which 75mio will be delivered in Q2. The additional, new option of 100mio will be dealt with later.

This table replaces the previous (blue) columns for Top Up.

Comments to the table:

5.1.2a [redacted] and Poland have been allowed to catch up and recoup the pro rata from the 50+50mio previous options.

After that the remaining doses (189mio) are divided pro rata across all countries.

Finally, the countries that "lent" doses to 5.1.2a and PL from the Options get their doses back from 5.1.2e and PL.

This is now a re-set, that is, those that commented on the Top Up before today's news will have to reconsider and resubmit to me what you want:

Keep the pro rata

Take less doses

Request more doses

I know that BG already said they want zero (are you sure?) and that DK SE NO for sure want more.

Please send your comments as soon as you can. We will discuss next at the SB Monday at 17CET. And please always copy EC-
