Hi all

Thanks, 5.1.2e for the good minutes.

My 'take home' messages from our discussion are:

• Both reviews did not find many studies that focused primarily on communication between health care workers (HCWs) and older adults (note that the effects review focused on HCW focused interventions only)

• Most studies in both reviews were focused rather on increasing vaccination uptake, and this restricts the data we have available on communication issues and how these impact on vaccination choices. This finding regarding the studies identified is congruent with other reviews in the vaccination field which also show that studies seldom emphasise communication and informed decision making.

• Future trials may want to consider the factors identified in the QES when planning interventions that are intended to improve communication between HCWs and older adults, with the aim of informing choices among older adults regarding vaccination

• The effects review suggests that educational interventions alone may not be very effective, and that other components may need to be added to educational interventions. The QES includes some suggestions on what these other components should cover. This is important for the VITAL training platform for HCWs
