## Team expansion

## Vaccine Coverage

Denominators and numerators of home dwelling elderly are mixed up with elderly living in care homes.

5.1.2e made an excel sheet "Overview vaccination data per age", to be discussed with 5.1.2e

Check the statline to get numbers of care homes and handicapped facilities. This is a lower number than the work package number of all long term care facilities.

The denominator is rough  $\rightarrow$  as of 1-6-2020, the numbers of handicapped facilities will not change the denominator enormously. Coverage of 90+ age is 97%.

#### BES

5.1.2e discussed for BES to give the options to be centrally registered in RES and not in CIMS. BES authorities are a bit hesitant, but we try to convince them. Hesitancy is that people will not want to be vaccinated when registered.

BES have ID-numbers and an Island code instead of BSN and postal code. Legally there is no reason why BES should not be registered in CIMS.

#### CAS

For CAS we will receive anonymous data as of 22-02-2021.

eported RIVM will probably only have aggregated data;  $1^{\rm st}$  and  $2^{\rm nd}$  dose will not be on the same line.

The weekly update will provide separate BES and CAS paragraphs for the press. Advising to make separate documents because we need approval of the separate islands.

5.1.2e contacts the contact person how to collect the data and will discuss separate reporting for BES and CAS.

BES and CAS data does not have to be published on the national dashboard.

## Vaccine efficacy

In Osiris: the most recent data/numbers of vaccinated health care workers in hospital are available.

The numbers of vaccinated long care workers (care homes) are only specified into long care and 24-hours care.

## Wrong way of transportation

Data of vaccines that might not work because of wrong transportation is very important. We need to be able to follow this matter very strictly to see what effect wrong transportation has on vaccines and efficacy.

# Incident issues 5.1.2e

15 cases of epileptic seizures after vaccination (of which 1 death, a person with underlying clinical picture). Most (at least 11) had epilepsy in history. Media attention for fatal cases after vaccination, reported by Lareb. Up till now, 26 deaths are reported.

Remarkably few reports of adverse events in the elderly were received by Lareb.

CGB reports they receive info from other countries. NL is doing okay, only anaphylactic reactions seems to be a little higher compared to f.i. the USA. No anaphylactic reactions this week up to now.

Any other business: no particularities.
