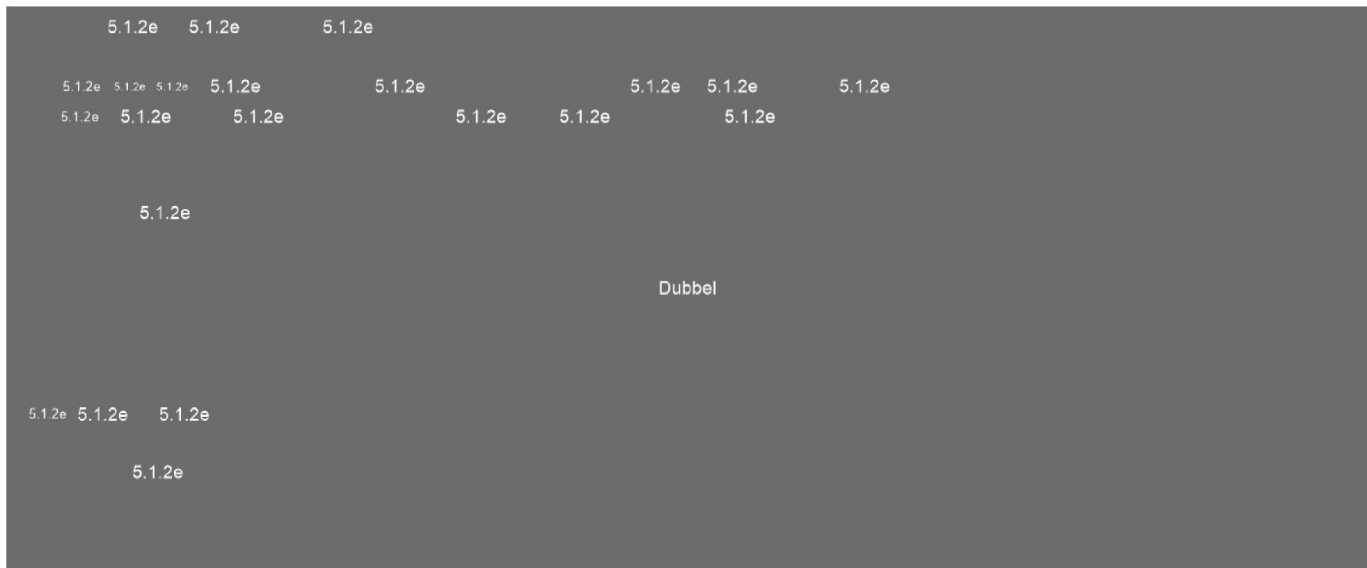

Here is our testing/quarantine/isolation strategy.

We are tweaking recently with more recent advice with regards to handling persistent positives and recoveries.

Generally speaking persons who have laboratory confirmation of previous positive and recovery who test positive by PCR with high CT values over 33 are considered persistent positive and cleared and treated as negative.

I reached out to the local Basketball Association and they were not aware of a team travelling to Statia. They will research and revert to me.

Dear colleague,

I will liaise with my colleagues from Statia to get more details concerning the planning of this sports event. If I look at your epidemiology screening before leaving would not make much sense. Much of the risk during such an event depends on the way the travel is being organized. There has been no local transmission on Statia for a few months either. So let us decide on screening and quarantine later on.

We would also be interested in your view of an exit strategy from this crisis that has also severe social and economic impact on these relatively small island communities for an important part depending on tourism as their source of income. Immunization programs would offer a way out, what coverage would be necessary en would you include the younger age cohorts in order to reach a level of immunity necessary to re-open touristic activities without too many precautionary measures interfering with the industry? Have you been able to draft a plan on such a strategy?

The recently diagnosed persons are all related to travel quarantine. We have no cases arising from the community recently and no evidence of local transmission. We are classified as THN level I by the US CDC at this moment based on the information that we submit to them periodically. So risk of transmission locally is considered very low.

In my view the team should be screened before travel. I am not aware of your entry quarantine requirements but they should be subjected to whatever entry requirements that you have.

I will make contact with the BVI Basketball Association and determine who is planning to travel and how they plan to travel. If you would like any specific entry screening to be done I will be happy to facilitate.

In the interim kindly let me know what further assistance I can give

Dear 5.1.2e

I am responsible for advice for our national government concerning COVID-related problems on the Dutch OTC. Sint Eustatius is one of our smaller islands with a population of about 3000. They have practiced a containment strategy, and the number of patient during this epidemic was quite limited (20 in total, mostly imported in quarantine) with once limited local transmission, quite quickly brought under control. Quite comparable to the situation on your islands. It seems there are plans for bringing in a basketball team from BVI to Statia. I don't know exactly when. The question was what precautionary measure would be necessary. Now I understand from Autilia that there is no local transmission in your territory, so if it is a designated straight local flight risks are quite limited, and extensive testing may not be indicated. If on the contrary it concerns an international mixed flight through other airports more precaution might be needed. From the WHO/PAHO site I could see quite a few diagnoses made from your territory during past months. Could you explain the local epidemiological situation and your view on exchange of such sporting teams?
