Some of the loggers did not register the correct times on the temperature logger print-outs and so showed an inaccurate start time and end time . The start time and the end time of the test are accurately noted in the IOPQ validation report.

The loggers registered the initial logger turn on temperature before putting them in the fridge and it also registered the transport time after the test (the time it took for us to walk back to our office), this is the root cause for the high values which contributed to higher average.

Attached is a clearer read out of the open door test and also the logger certificates.

A Phone call will indeed be easier I think, we can better explain the reasoning behind some of the data.

I have received the validation report from 5.1.2e many thanks for completing it.

I am responsible for verifying the IQOQPQ report. I do have some questions where I hope you can help me:

1. I do miss some data of the loggers:

24h mapping test from 12JAN 3:13 pm to 13JAN 3:13 pm

- Logger 1: data report starts at 5:29 pm (and was then 25.4 degrees)
- Logger 5: data report starts at 5:27 pm (and was then 25.4 degrees)
- Logger 7: data report starts at 5:26 pm (and was then 26.5 degrees)
- Logger 8: data report starts at 5:13 pm (and was then 26.5 degrees)
- Logger 10: data report starts at 5:26 pm (and was then 26.5 degrees)

Open door test from 13JAN 4:53 pm to 6:53 pm

- Logger 1-6: data report starts at 20:09 pm
- Logger 7: data report starts at 4:18 pm, 4:48 pm the refrigerator was 8 degrees, not a good start for an open door test.
- Logger 8 -10, see logger 7 with unreadable data until 4:38 pm

Power failure test 14JAN 2:10 pm (power on 3:10 pm) to 5:10 pm

- Logger 2-5 : data report starts at 17:00 pm

2. The average, highest and lowest values (result 9.2 in protocol) are based on the temperatures including stability time. Is this assumption correct? Because the test results of 24h mapping can start when the 24 hours start in this case 12JAN 3:13 pm.

3. I see at the start of some tests that loggers have extreme high values (for example: 25 degrees 2 hours after the test, see the 24h mapping). Can you confirm this is correct? Can you explain the root cause? Were the loggers in the refrigerator at time of the 24h mapping?

4. Is it possible to also send me the excel data, so that I can calculate the average?

5. The calibration section has not been completed, as you do not know what it is. My question is if there was a kind of certificate included by the loggers. It is a one page document.

I am more than happy to discuss my issues by phone, maybe that is easier.
