Het enig wat ik zo vermeld zie in het contract, niet in alle, is dit: COVID-19 Support for the Dutch Caribbean on the Islands of Sint Maarten, [REDACTED] and [REDACTED]

CoVID support is daarbij niet echt nader gespecificeerd.

Graag nogmaals jullie input, bij akkoord stuur ik het naar AMI.

@ [REDACTED] naar aanleiding van ons gesprek vanmiddag heb ik het contract gestuurd naar [REDACTED] In contract staat dat we AMI 30 dagen voor afloop contract moeten inlichten of we wel/niet door willen.

Dit hebben we gedaan op 28 januari en bevestigd met een mail incl afspraken. Dit is voldoende en mail kan aan het dossier toegevoegd worden. [REDACTED] Dat is handig!

Hi [REDACTED], as agreed in our conversation of 10 February, I will send you a number of terms that we would like to include extra in the new contract.

Total extension contract is 6 months. 1<sup>st</sup> of March until 1<sup>st</sup> of September 2021.

#### To be included in Exhibit A (services)

From 1<sup>st</sup> of March until 1<sup>st</sup> of June 2021:

- Required numbers of staff: 100. If necessary, the possibility of deploying additional staff from AMI according to the needs of the venues in the Caribbean.

- The composition of the teams is determined according to the needs of the hospital. The hospital communicates with the Ministry of Health and Welfare, the Ministry of Health and Welfare will communicate team composition to AMI.
- COVID care is priority, if necessary staff can be deployed flexibly within the hospital.

- If required, members of AMI's clinical team will be deploy to other venues in the Caribbean to provide clinical support to other medical operations
- Deployment of the staff for a minimum of 6 weeks

At the beginning of May 2021, the exact numbers of required staff for the period up to 1 September will be communicated to AMI.

From 1<sup>st</sup> of June until the 1<sup>st</sup> of September 2021

- Flexible deployment of the staff in numbers. We expect that the pressure on hospital care will decrease over the course of the months (due to vaccination) and that in the long term less staffing will be required.
- The composition of the teams is determined according to the needs of the hospital. The hospital communicates with the Ministry of Health and Welfare, the Ministry of Health and Welfare will communicate team composition to AMI.
- COVID care is priority, if necessary staff can be deployed flexibly within the hospital.
- If required, members of AMI's clinical team will be deploy to other venues in the Caribbean to provide clinical support to other medical operations
- Deployment of the staff for a minimum of 6 weeks

AMI will make sure its own staff is vaccinated. From 1 April 2021, everyone who is going to work on the islands must be vaccinated

To be included in Exhibit B

The overpaid amount will be reimbursed to the Ministry of Health and Welfare prior to the new contract. Or a payment arrangement is included in the contract. 5.1.2e Ik zou zeggen overpayment (en de periode noemen) in plaats van the overpaid amount.

To be included in general

In connection with rule and legislation in the Netherlands, we need to include an ARVODI in the contract. The ARVODI offer a uniform set of general terms and conditions for service agreements between the state of the Netherlands and third parties.
