Dear EHPPA Members,

I hope you are all doing well.

I have a message from the European Commission and it could be nice if EHPPA can contribute on this issue:

*"The Commission has made structural arrangements to strengthen the short to mid-term industrial solutions to fight against Covid-19 and other bio-threats. A new Task Force, led by Commissioner Breton, has been set to ramp up production capacity for vaccines, acting as a one-stop-shop for manufacturers in need of support. Commissioner Breton will work in cooperation with Commissioner Kyriakides regarding health and regulatory aspects. The Task Force has three main work streams:*

- *eliminate bottlenecks in current production, accelerate and upscale it where feasible.*
- *adjust vaccine production to virus variants;*
- *work on a structural plan for faster response to biohazards at the European level.*

*The first priority is now a mapping exercise of existing and potential production capacity and the identification of existing/potential bottlenecks in the production and/or administration of already available vaccines or new vaccines which are likely to get an EU marketing."*

The general idea is to identify all the companies who are producing some of the components for the production of Covid-19 vaccines. Here you can find an article which lists the different components of these vaccines:
