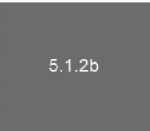

I hope that you had a nice weekend and thank you again for your assistance this weekend in securing the charter for our team of 10 nurses to transfer from Curacao to Aruba.

As discussed last Friday, we are finalizing the invoice adjustment back-up information and will be able to provide that to you tomorrow. Once received, we are happy to set up either in-person or virtual meetings to go through the numbers with you in more detail is required.

Separately however, today is the last day of our current contract and we need to get an addendum in place to extend the contract so that our team is not operating at risk starting tomorrow. Our recommendation is to extend the contract at the same staffing levels and rates that are currently being billed through June 30th. This will also provide us the flexibility to begin the staffing conversations again in May to review the staffing posture from June-September. Please let us know your thoughts on this recommendation and we will be happy to put this Addendum together to send for your review and signature today.

We continue to prioritize the invoice adjustment and will have the requested information to you by Tuesday, if not sooner.

In addition, we are happy to coordinate in-person meetings with you and our team either in The Netherlands or here in Reston or conduct a series of virtual video calls with you to walk you through this process even further if necessary.

Once we have determined and mutually agreed upon the credit amount, we can work with our Senior Leadership team to determine a payment schedule for the total amount.

In regards to the pricing that we provided, this was based upon the assumption that this discount would be applied across the new six-month contract term. As it appears that this will not be possible to do in the new contract, I would like to propose that we draw up an Addendum to extend our current contract from March 1st-June 30th at the same staffing levels and same rates as are currently being billed. If you agree to this, we will work with our contracts team to have the Addendum drawn up and sent to your review ASAP. At this time, we can also review the contract language that you sent to us and requested to be included in the new contract.

Our current contract expires on Monday, March 1 so we are happy to discuss this further with you today, over the weekend, and/or on Monday to make sure that our team is not operating at risk with no contract in place starting next Tuesday.

Regarding the vaccination strategy, we will work to get you a proposal based upon a rotation strategy where we bring our staff back to the United States in order to receive their vaccine for those that want to have the vaccine administered to them ASAP.

Thank you for the read-ahead.

Internally, we talked about your proposal. We believe that, as we are working towards a phase-out schedule in the coming months, it is wise to offset the costs in advance.

With respect to the correction on the invoices April-Augustus: We need to receive detailed information about the correction. How did you end up with this correction? We expect to see the schemes of rotation with explicit information so that we can see that the position was not filled in and that therefore a correction is needed. AMI is by far our largest contract, the auditor of VWS is asking very detailed questions on our payments to AMI. Transparency is important in our governmental system. We request all the information you've got, so that we can recalculate the numbers ourselves as well. We also need to be in the position to be able to check all your invoices with the hospitals.

Delivering the results should be AMI's priority. We need this information by Tuesday at the latest!

To settle the credit we think it is best to do this as an credit on the invoices of January. This way the credit amount is settled immediately and there will be no mix-up with the new contract and payments.

In the beginning of May, we will jointly assess what is desirable and feasible in terms of costs and staff numbers for both hospitals and AMI in terms of phasing-out schedule. At the moment it is not possible for us to give a specific number given the uncertainties that lie ahead.

As far as vaccination is concerned, we have agreed internally that vaccination of AMI personnel for political reasons is best done through AMI's own facilities. We think a rotation schedule, where staff are brought to Miami and back to the island, will be best workable. Therefore we would like to receive a proposal regarding the approach to the vaccination rotation schedule.

In addition, we wondered whether the U.S. Consulate on Curacao might play a role in the organization of vaccines to the island for AMI?
