Last week was very intense, busy with many checks: we really tried whatever possible to satisfy your request.

Bottom line, we had to conclude that it is not possible to produce in our site in Switzerland the amount of hand sanitizer that 5.1.2e requested us (we also checked if it was an option to produce the sanitizing agent in one site we have close by here, in Grenzach, with the same result – even longer registration procedures, in Germany!).

We would need a new product registration and a special license, since the product contains alcohol.

I also checked with my colleagues in Delft, but also there it is not possible to arrange production on short term, as they would need an engineering solution to implement a safe unloading of the product.

I very much regret this, but we are unfortunately unable to help.
