There is no set type of mask. Any disposable face mask will suffice.

I have spoken with 5.1.2e and took onboard their view that this is an EMA requirement they will comply with, but they are not in the position to provide masks, as this also comes against the instructions from Dutch authorities who requested that masks should be kept for medical use, in order to support the medical services. I have informed 5.1.2e about this and we are seeking further advice from management.

I will get back to you later today, once I receive further clarifications from senior management on a way forward.

Dear all,

Please ensure that all your team on site and as well all contractors coming on site as of today, wear a protective mask. (This also applies to EMA staff and everyone in the building)

The only exceptions are contractors who because of the nature of their work cannot wear one, but I doubt we have such cases.

For today, EMA will provide 2 masks to everyone in the building (both EMA and all contractors). Security will start handing over these masks shortly.

As of tomorrow, contractors must come prepared with their own protective masks. In the odd case where a contractor could not procure one due to the short notice, then EMA may provide one from its stock, exceptionally. Further clarifications will come. [REDACTED] can we have a catch-up call at 14:30 today?

Meanwhile, please inform immediately everyone under your supervision working on site that once the mask is provided today it must be worn at all times inside the building. Who does not respect the rule will be escorted outside the premises.
