**Subject:** Summary of phone calls about the Dasheng masks

Derar all,

I hereby summarize the call with [5.1.2e] (agent of de [5.1.2e]), and the call with [5.1.2e] (<http://en.dashengmask.com/>) .

#### Call with Lisa Morning 21st March

- [5.1.2e] will arrival in [5.1.2a] 2pm coming Sunday, she is available for a visit to Dasheng around 4pm Sunday. She will stay in Shanghai for the coming week.
- [5.1.2e] thinks [5.1.2e] has the mask product & production capacity, which are needed by NL. The only issue is that [5.1.2e] cannot sell the products freely, due to a control of local government.
- [5.1.2e] thinks that direct communication between Dutch government and the local [5.1.2a] government can help to resolve the issue.

Request of [5.1.2e]

- Embassy/Consulate sends some (Dutch) colleague to visit Dasheng together with her on Sunday,
- OR preferably, communicate with local government, and get the support from local government, and then visit Dasheng together

#### Call with [5.1.2e] together with [5.1.2e] Afternoon 20th March

- Dasheng has not enough product in stock, not enough capacity for FFP2 medical use masks,
- Local government is in control of some of the production, and most importantly, in control of the supply of an essential raw material.
- Dasheng provides more than 100 types of masks. Embassy/Consulate is welcome to check out if there are other types of masks which are acceptable
- [5.1.2e] will not sign any contract, as the future production can not be guaranteed due to the unstable supply of raw material
