For your information:

I connected Joyce with a representative of Zhende ([www.zhende.com](http://www.zhende.com)) yesterday, they are a medical supplies manufacturer from Shaoxing, Zhejiang and make masks and protective suits amongst others [redacted] 5.1.2e is in direct contact with them.

This morning in a Dutch wechat group some people asked how they could get in touch with the government about sending masks to the Netherlands so I shared the email address [coronabeschermingsmiddelen@minvws.nl](mailto:coronabeschermingsmiddelen@minvws.nl) (which Minister Bruins shared on Twitter) with the group. Mr [redacted] 5.1.2e based in Guangzhou) and Mr. [redacted] 5.1.2e (based in Qingdao) will send more information there. Some people (including myself) also mentioned that it is important that the right masks are sent to the Netherlands, people should pay attention to the performance and quality requirements and deal only with trustworthy parties.

Mr. [redacted] 5.1.2e just shared a message in the group that he talked to the embassy extensively and he mentioned the embassy is getting information about supplies from China but it will take a while, so people should go on with replying to individual requests of hospitals and other institutes in the Netherlands. I assume that is indeed the advice he received from 'the embassy'?
