In it they assessed the impact of five non-pharmaceutical interventions (NPI) on the epidemic. The report also states "Stopping mass gatherings is predicted to have relatively little impact (results not shown)"

It would be very interesting to know if others also have done similar epidemic modelling assessing NPI's. With many governments implementing very strict, but non-evidence based restrictions, it would be good to be able to say that it probably doesn't work. Since this pandemic will last for quite some time, we need to stop the non-effective NPI's.
