Following our audio meeting of yesterday, please find attached a file with contacts of companies that could be suppliers of essential supplies and equipment.

These were sent by companies that have contacted the Commission directly and by the Chinese Embassy in Brussels. We have not validated, filtered or endorsed them.

We also note a point of potential relevance when you consider emergency measures related to PPE (this was brought to our attention today): for the production of essential medical products to continue, some masks may have to be allotted to the companies producing them.
