3. To make this donation move forward **please provide the below information by Today**:

Shipping

- 1) Recipient full name (government agency or NGO required), contact person full name, address, phone number and email address
- 2) Complete shipping Address, contact person full name, phone number and email address
- 3) Consignee's IOR (importer of record) and EORI number
- 4) A formal letter from the recipient written on recipient letterhead paper with attention to China Customs, The letter should contain information of name of donor, name and quantity of donation items and states that the donation is free and will be free of charge for distribution.
- 4) Notify the sender if recipient's customs requires any wording of "Donation for Humanitarian Aid" or "Donation supplies" on related paperwork, like AWB, Packing list etc.

Qualification

- 1) Confirm the designated customs logistics operator is capable of and holds relevant certificates in handling customs clearance, tariff if there is, goods withdraw and transportation at arriving airport
- 2) Confirm the operator and recipient hold relevant medical license to clear special medical supplies in customs if any applicable in the donation.
- 3) Confirm the recipient is capable of acquiring exemption approval or completing necessary procedure to clear customs of donation items that do not possess receiving country's standard certificate or approval, e.g. EU CE, US FDA etc. if any applicable in the donation.

Information for T1

- 1) Recipient needs to sign a trust agreement with SINOTRANS Liege;
- 2) Recipient needs to provide Customs ID, Agency in NL.
- 3) Recipient's WH is bonded or not, if not
- 4) if Recipient's customs requires any special requirements for AWB, packing list and invoice, please notice one day in advance before flight departure.
- 5) Any other documents required for T1 also included.
