**Update:** Since the previous RT report published on 6 March 2020 and as of 7 March 2020, 3 241 new cases of COVID-19 (in accordance with the applied case definitions in the affected countries) and 103 new deaths have been reported. Eight countries have reported cases for the first time: Cameroon, Colombia, Costa Rica, Peru, Serbia, Slovakia, the Holy See, and Togo.

New cases have been reported from Iran (1 234), South Korea (483), Germany (284), France (190), Switzerland (122), Spain (113), United States (105), China (101), Sweden (76), Japan (59), Belgium (59), Italy (58), United Kingdom (48), Netherlands (46), Malaysia (33), Austria (33), Norway (27), Singapore (13), Greece (13), Egypt (12), Palestine\* (9), Iceland (8), Czech Republic (7), Finland (7), Argentina (6), Canada (6), Lebanon (6), Russia (6), Brazil (5), Estonia (5), Ireland (5), Bahrain (4), Poland (4), Portugal (4), Australia (4), Qatar (3), Thailand (3), Azerbaijan (3), Denmark (3), Slovenia (3), India (2), Indonesia (2), Israel (2), Philippines (2), Hungary (2), Luxembourg (2), North Macedonia (2), Cameroon (1), Togo (1), Chile (1), Colombia (1), Costa Rica (1), Dominican Republic (1), Peru (1), Pakistan (1), Taiwan (1), Vietnam (1), Croatia (1), Romania (1), San Marino (1), Serbia (1), Slovakia (1), the Holy See (1) and New Zealand (1).

New deaths have been reported from Italy (49), China (28), Iran (17), United States (2), South Korea (2), France (2), Spain (2) and Netherlands (1).

#### **Major developments in the EU/EEA and the UK:**

**Italy:** [Italy](#) reported 3 916 cases of COVID-19 and 197 deaths. This is an increase of 58 cases and 49 deaths since yesterday.

**Germany:** [Germany](#) reported 684 cases of COVID-19 and no deaths. This is an increase of 284 cases since yesterday.

**France:** [France](#) reported 613 cases of COVID-19 and nine deaths. This is an increase of 190 cases and two deaths since yesterday.

**Spain:** [Spain](#) reported 374 cases of COVID-19 and five deaths. This is an increase of 113 cases and two deaths since yesterday.

**United Kingdom:** The [United Kingdom](#) reported 163 cases of COVID-19 and one death. This is an increase of 48 cases since yesterday.

**Netherlands:** The [Netherlands](#) reported 128 cases and the first death. This is an increase of 46 cases since yesterday.

**Slovakia:** Through EWRS Slovakia reported the first case in the country. The case has no travel history.

**Other updates:**

**Cameroon:** On 6 March, [authorities](#) reported the first case in the country. The case is a French citizen who arrived in the country on 24 February 2020.

**Peru:** On 6 March, [authorities](#) reported the first case in the country. The case has travel history to France, Spain and Czech Republic.

**Summary:** Since 31 December 2019 and as of 7 March 2020, 101 412 cases of COVID-19 (in accordance with the applied case definitions in the affected countries) have been reported, including 3 488 deaths. The deaths have been reported from China (3 072), Italy (197), Iran (124), South Korea (44), United States Of America (14), France (9), International conveyance in Japan (6), Japan (6), Spain (5), Australia (2), Iraq (2), Netherlands (1), Philippines (1), San Marino (1), Switzerland (1), Taiwan (1), Thailand (1) and United Kingdom (1).

**Cases have been reported in the following continents:**

**America:** United States Of America (338), Canada (51), Brazil (13), Ecuador (13), Argentina (8), Chile (5), Mexico (5), Dominican Republic (2), Colombia (1), Costa Rica (1) and Peru (1).

**Europe:** Italy (3 916), Germany (684), France (613), Spain (374), Switzerland (209), United Kingdom (163), Sweden (137), Netherlands (128), Norway (113), Belgium (109), Austria (74), Greece (45), Iceland (43), Denmark (23), San Marino (23), Czech Republic (19), Finland (19), Ireland (18), Portugal (13), Croatia (11), Estonia (10), Russia (10), Azerbaijan (9), Georgia (9), Slovenia (9), Romania (7), Belarus (6), Poland (5), Hungary (4), Luxembourg (3), North Macedonia (3), Bosnia And Herzegovina (2), Andorra (1), Armenia (1), Holy See Vatican City State (1), Latvia (1), Liechtenstein (1), Lithuania (1), Monaco (1), Serbia (1), Slovakia (1) and Ukraine (1).

As of 7 March 2020, 213 deaths have been reported in the EU/EEA and the UK: Italy (197), France (9), Spain (5), Netherlands (1) and United Kingdom (1).
