Enclosed please find the syndromic surveillance reports for epi wks 11 thru 14 from Curaçao, St. Maarten & the BES islands.

As you know, COVID-19 is dominating the work efforts on all of our islands.

Curaçao has 14 confirmed cases to date with 1 deceased. St. Maarten has 50 confirmed cases with 9 deceased. Bonaire and Saba have no confirmed cases, while St. Eustatius has 2 confirmed imported cases.

As far as the syndromic surveillance is concerned, this has also been affected due to lockdowns in place in Curaçao as well as in St. Maarten. These measures were implemented after local transmission was determined.

In St. Maarten there was low participation of the sentinel stations in wk 14.

In St Eustatius Respiratory disease seems to be in decline. Aside from the imported COVID-19 cases, mycoplasma Pneumoniae was detected in wk 12.
