Dear Partners,

The Public Health Agency of Sweden would like to clarify that this advice from the working group of the Healthy Gateways does not reflect the opinion of the Agency. As we have stated to the Healthy Gateways, we recommend that in all matters on advising about face masks we should be guided by the guidelines from sources with the best scientific knowledge. In this case it would be WHO and ECDC. The risk when a Joint Action gives specific advice/recommendations in an area is that it signals that they have access to more knowledge/information than WHO/ECDC. The Public Health Agency of Sweden have not seen any new scientific evidence that motivates this advice.
