Sorry for the delay in getting back to you. We have tried to figure out the volumes in the various EU contracts.

Our understanding now for FFP2 is that actually the quota for Estonia is not 6 million masks but around 2.8 million, if you look at the maximum capacities of each tenderer. And please, correct me if we have got it wrong, because there are so many unclarities around these joint procurements.

We most probably would have some spare volume of FFP2, however under 3M contract our share would likely to be used to the maximum.

I am sorry, I can't give a definite answer yet on FFP2 surplus but as soon as we have managed to clear out all the details, I will let you know.

For FFP3, we are looking to order 400-500 thousand masks. You said that you have been in touch with Medicom. Do you think that they could have spare capacity to accommodate our request (even if partly) and what the expected delivery times are?

Thanks for a quick response!

Looking at the FWC Lot 3 (FFP2 - 3m), I notice that your country signed up for roughly 6 mio FFP2 masks with 3M. The amount we are considering is several millions FFP2 masks, so we would be pleased with any quantity Estonia could make available to us.

We have already most of our share under the FWC of FFP3 masks (Lot 4) from Medicom utilized, but still might have available a couple of million FFP3 masks available under the FWC with Vara Home Fashion (exact amount to be checked with our MoH - since we have a bank holiday today I'll have to wait for a response till tomorrow).
