Dear [redacted] (5.1.2e)

At present there is still a critical shortage of personal protective equipment, such as isolation coveralls and drapes and respiratory masks, in healthcare. Therefore, the Dutch National Institute for Public Health and the Environment (RIVM), at the request of the Dutch Ministry for Health, Welfare and Sport (VWS), has performed a study into such products. Concerning isolation coveralls and drapes, they concluded that the only viable reprocessing method for a wide variety of products will be irradiation with gamma radiation, which is operated by your company in the Netherlands.

We, as the Ministry of VWS, like to urgently ask you to make gamma irradiation also available for reprocessing isolation coveralls and drapes and respiratory masks, when asked for by Dutch health care facilities. We are aware that this is outside your normal mode of operation, but due to the imminent shortages, temporary solutions are called for.

Can you let us know if you can make your irradiation facilities available to Dutch health care facilities? Please let us know if you need more information or something else to facilitate this decision.
