Beste 5.1.2e

Ter voorbereiding op de meeting morgen, stuur ik alvast wat informatie, wat betrekking heeft op de inrichting en het operationeel maken van de ICU tent/Hospitainer.

Er heeft een assessment plaatsgevonden waaruit een aantal punten kwam die wij zelf zullen oppakken, maar sommige willen we graag met jullie bespreken (in geel):

Based on our walk through we had with rep's from AMI and our nursing and specialists we made the following observations:

- 1) Beds, missing side rails. Can the side rails for the provided beds be delivered?
 - 2) Beds do not need 'papagaai' for this type of patient and those will be removed from the beds by biomed SMMC.
 - 3) Beds only operate electrical, not functioning as yet which is checked by SMMC biomeds
 - 4) Mindray patient monitoring system, IBM cable and Co2 probe seems not to be delivered. Central station is set up in supporting tent and operational.
 - 5) Consumables (BP cuffs, finger probe, etc) patient monitoring system are reusable, which is not recommended for Covid-Care
 - 6) Syringe pump, 1 per bed delivered. In our current setting we use 3 per ICU bed which is required to provide the care.
 - 7) Disposable syringes for the provide pumps seems not delivered. To verify if SMMC syringes can be used.
 - 8) IV pumps, 0 delivered. In our current setting we use 4 per ICU bed which is required to provide the care.
 - 9) Defibrillator is 3 leads, 12 leads preferred.
 - 10) Radio's 4-5 needed to communicate between ICU tent and supporting tent. SMMC ICT to provide
 - 11) Cell phone needed to communicate with SMMC specialists, nurses. SMMC ICT to provide, including a phone list.
 - 12) Happy ventilators do not have the parameters which are needed to provide care to Covid patients.
 - 13) Draeger ventilators could be used for ICU tent, but we expecting that they cannot provide the long-term ventilation to patients with complicated/compromised lung problems as ARDS.
 - 14) Draeger ventilators run only for oxygen supply pressure of 2.7 – 6 bar. Provided Oxygen concentrators for tent only produce upto 1.38 bar. SMMC needs to find alternative oxygen supply (safe for in tent) or other ventilators.
 - 15) Trolley for crash cart needed, to have all supplies at hand when CPS arise. We ordered, in the mean time until arriving an alternative trolley is placed.
 - 16) Big red waste containers to be placed, as they need to be foot operated. SMMC facility will place one.
 - 17) Have point of contact for facility/maintenance/ICT questions available (equipment, tent, etc)
 - 18) Have facility support available (cleaning schedule, waste pick-up, empty potty, fill water tanks, empty dirty water tanks, etc)
 - 19) As this is a critical facility we are verifying if we need to place an UPS to make sure when there is power interruption (technical issue generator, switching between generators) we do not lose power to the critical equipment. This is checked with a local supplier, who also assisted in the installation of the bigger fuel tank, as the generators came only with a (small) 40L tank. Currently we only need to fuel up every 3 days instead of every 8 hours.
 - 20) GEBE electricity connection (110V – 60Hz) will be brought to tent area. This to have computers, regular changing points phones etc available and maybe to connect some additional equipment from SMMC in tent.

Wat punt 12 betreft, is een beschrijving van de conclusies bijgevoegd in de bijlage.

Wat het installeren van de containers betreft, hebben [redacted] er [redacted] vandaag gekeken naar de layout die wij gisteren en vandaag ontvingen van Hospitainer, alsmede en het installatieplan (en planning van de mensen die ingevlogen worden om de installatie te doen). Ook dat willen we graag met jullie bespreken.
