D4.6 Systematic review of highly effective educational interventions (M22)

D4.7 Systematic review of qualitative studies of barriers and facilitators to the uptake of educational interventions (M22)

D4.8 Workshop with representatives of HCW/HCP to select potential training and education interventions that match the different needs (M24)

Due to COVID-pandemic, healthcare workers could not be included in the study because of very high workload, resulting in a delay of deliverable D.4.4. In addition, most partners of work package 4 were also included in the control of the COVID-19 pandemic, resulting in a delay of deliverable D.4.6 and 4.7.

Because the studies/projects of work package 4 are consecutively planned, the deliverables that need input from the healthcare professional study and the systematics reviews are also delayed (D.4.5 and D.4.6)
