Please do not reply to the invitation via email. To access the registration form, you will be asked to enter your existing ECDC credentials.

Our aim is to circulate the invitation from SRM (including draft programme) around 1 March 2021. Please note that it is of utmost importance that you accept or decline your participation within the deadline indicated in the invitation. After the deadline, the registration will close automatically. Close to the deadline, a reminder for registration will be sent automatically. All the participants who accepted the meeting will subsequently receive another email providing them with the connection details to the virtual meeting.

For information, the 51st Management Board meeting will convene via Webex as previously. The meeting is scheduled to take place on **Wednesday, 24 March at 9:30-14:30 CET** (a one hour lunch break is planned at 12:15 CET).

After the meeting, we will investigate any feedback received from you about this new way of organising virtual meetings via SRM, and will accommodate the necessary improvements in the system.
