The UK strategy is underlined by prioritising the first jab as set out by the JCVI statement given the protection that provides. <https://www.gov.uk/government/publications/prioritising-the-first-covid-19-vaccine-dose-jcvi-statement>

But the strategy also remains to administer the second jab within a 12 week window. PM Johnson said last week: "We will have the second doses people need within the 12 week window, which means around 12 million people in April, and we will still offer a first dose to every adult by the end of July".

So it is still the case we aim to administer the second jab within 12 weeks, whilst prioritising the first jab.
