

## Description of the activities using the additional budget and staff allocated to ECDC in 2021

## 1. Background

During its 50<sup>th</sup> meeting in November 2020, the Management Board adopted the Single Programming Document 2021-2023. ECDC started its implementation in January 2021. In parallel, additional budget and positions were granted to ECDC through an amended EU budget 2021, as agreed in the Multiannual Financial Framework (MFF) 2021-2027.

An amendment of the Single Programming Document 2021-2023 was presented to the Management Board through written consultation in February 2021. The outcome of this consultation was the approval of the amended document. At the same time, following the observations expressed by some countries, the Management Board chair requested ECDC to describe in further detail the new activities the Centre proposes to initiate in 2021, and the planned activities that it proposes to strengthen using the additional budget and staff members allocated in 2021.

## 2. Description of the additional and strengthened activities in the SPD 2021-2023

A consultancy will subsequently advise ECDC on the best IT solutions to implement the blueprint. In collaboration with the European Commission, a second contract for whole genome sequencing services is being prepared and can become operational in the end of March 2021. 		In 2020, work was initiated to develop metrics and indicators for emergency preparedness, exploring the areas of laboratory testing, surveillance, risk communication strategies and healthcare system coordination. The continuation of this work in 2021 will be based on the analysis of COVID-19 plans and indicators used to measure progress in these areas. The aim of this project is to develop a framework/matrix and measurement approaches for preparedness in consultation with the MS and the European Commission.	€ 130 000 for Public health Emergency preparedness metrics, planning indicators and guidance	
		Work with the European Commission on revising the template for reporting on preparedness and response planning will continue in 2021, for the documentation to be finalized for the foreseen reporting by the end of November 2021. Moreover, it is foreseen for ECDC to work with EC on these reports (every 2 years) for the Health Security Committee (HSC) containing the analysis of the data reported as well as country profiles for monitoring progress. For this task, dedicated human resources will be secured in 2021.
