We would like to thank you for nominating [REDACTED] to conduct the GCP inspections of two investigator sites, the sponsor and CRO sites in Russia, on behalf of the EMA. As a smooth and successful conduct of the inspections will be critical to the timely authorisation of the Covid-19 vaccine (Gam-COVID-Vac components I&II, aka Sputnik V) in the European Union and will help with increasing the availability of vaccines for the general public, the EMA would like to make sure that the inspection team is vaccinated against Covid-19 at least 3 weeks prior to the start of the inspection.

As this mission is very important from the public health perspective and inspectors falling ill before or during the inspection could hinder or jeopardise the inspection process, we would like to strongly recommend that the inspector [REDACTED] timely receives a Covid-19 vaccine.
