Goedemorgen,

Just following up on this email from Wednesday with the outcome of the visit and thank you also [redacted] for sharing the interesting information about DKs mission to purchase vaccines through their diplomatic missions (or at least the one in the Hague).

There were no concrete plans announced of a joint vaccine production facility, but intentions to collaborate on vaccine production and procurement. Netanyahu reportedly stated that other countries would also be welcome in the project. The Danish Prime Minister confirmed to media that while there were no material plans announced, the collaboration is more than a declaration of intention and that it was considered what the countries could contribute with now and in the future. According to the PM all three leaders wants to contribute with production on "own soil".

In an interview with Danish Media yesterday afternoon, the Danish Prime Minister confirmed that the purpose of the visit to Israel tomorrow 4 March (together with Austrian Chancellor Kurtz) is to investigate ways to increase vaccination production capacity. She

explained that one of the ways this could happen could be that Denmark, to build co-owned factories in Israel.

Denmark has for a long period lamented the slow rate of vaccine procurement through the EU and had not ruled out sourcing vaccines outside of the framework. This initiative would aim to increase the much needed capacity for vaccine production that is needed, as the Minister explained, to vaccinate Denmark's proximity countries, European peoples, show responsibility producing vaccines for Africa (and the rest of the world) and ensure supply for the potential need for re-vaccination [due to viral mutations].

The news broke yesterday in Danish media and the opposition was caught by surprise, first dismissing the notion of public vaccine production but hesitated with dismissing the idea completely.
