Dear 5.1.2e and Colleagues,

while approving these two documents, some MSs have expressed specific concerns on the content (for instance Germany and the Netherlands).

Would it be possible for you to describe in more detail the issues raised by some MSs, preferably all the titles of the new activities listed below? Our upcoming MB51 is such a short one to cover all this so I would very much appreciate a written reply for all before that.

"Most of the supplementary budget has been assigned in Title 3 as operational expenditure. It will be dedicated to new activities that ECDC proposes to initiate in 2021, and which are part of the amended Single Programming Document 2021-20231, namely:

- Blueprint for the future of EU/EEA surveillance, including a study on IT roadmap for integrated surveillance systems
- Takeover of the operation of the European Federation Gateway Service (EFGS), currently operated by the European Commission

The additional operational budget will also be used to reinforce the following planned activities, which are already part of the Work Programme 2021:

- Coordination of large-scale vaccine effectiveness studies on influenza and brand-specific COVID-19 vaccines
- Additional surveillance data management, analysis and GIS services
- SARS-CoV-2 whole genome sequencing services in support to the Member States
- Additional mathematical modelling support
- Further work on preparedness indicators
