The Commission would like to invite the Member States to a second meeting with the Task Force for Industrial Scale-up of COVID-19 vaccines on 30 March 2021 from 10:00-11:30, which I will have the pleasure of chairing again. The meeting follows up from the first meeting between the Task Force and Member States that took place on 17 March.

In this meeting, Member States will be informed about the state of play of the work of the Task Force, have the opportunity to listen to a presentation on the State Aid Temporary Framework by our colleagues from DG Competition, and to report on their own activities.
