Dear [5.1.2e]

I hope all is well. I've been asked by Cabinet Office whether it's possible to set up a meeting later this week or early next week on COVID-status certification as it is currently under review in the UK. The review is considering whether COVID-status certification could play a role in reopening the UK economy, reducing restrictions on social contact and improving safety. COVID-status certification as a concept involves using testing or vaccination data to confirm in different settings that people have a lower risk of getting sick with or transmitting COVID-19 to others.

As part of this review Cabinet Office would like to meet with the Netherlands to discuss your experiences of considering and/or implementing a domestic certification scheme. Particularly of interest are:

- a) How the government conceives of and designs a certification scheme and for what purpose it is being used (i.e. the policy framework)
- b) How the certification scheme is implemented and what the main challenges are (i.e. the delivery including digital and non-digital aspects of the certification solution)

On the UK side the meeting will be led at a senior official level - by [5.1.2e] Director in the Covid-19 Taskforce.

To note that the review is looking specifically at the potential role for certification in opening up the domestic economy. The question of certification for international travel is not directly in scope of the review, but is closely related.

Wilco, would you be able to help us find a relevant expert at the Ministry for [5.1.2e] to speak to?
