Subject: COVID / restrictions on movement to and from the UK

Dear colleagues, Croatian measures are as follows:

- Croatia introduced a ban on the entry of passengers from the UK into Croatia starting on 21 December 2020 at 00:00h, initially planned for 48 hours.
- The ban applies to the entry of passengers from the UK, so repatriation flights for UK-based passengers can be organized, if the incoming aircrafts arrive empty and their crew does not leave the aircraft while at the Croatian airport.
- Croatian citizens wishing to return home from the UK can fly to Croatia on these (otherwise passenger-free) incoming flights, however, it is necessary to announce and coordinate their arrival with the public health authorities (at each airport) in Croatia.
- Unaccompanied freight traffic is exempt from this ban, as are the health workers employed in the public health services.
