Unless I missed this, we haven't received a message on the technical problem with the case-based data, is that

correct?

Do you have any idea how long this will still take? If you expect this to take much more time, we can consider switching to the reporting of aggregated data by NCOVAGGR instead, but this will take quite some time for us to adjust our script to this reporting dataset.

Could you maybe tell me on the expected future of this case-based reporting; will the case-based reporting stop soon anyway, so it will be worthwhile to switch to the aggregated data, or will these two systems keep on existing in parallel?

Currently, we only report the sentinel covid data (by NCOVclassification on tuesday and for this first week via the influenza dataset on wednesday). We are working on the NCOVTEST, but because of the problems with the case-based reporting, only very little Dutch data is reported to ECDC.

Hope to hear from you and be updated on this issue.
