As I understand, Mediphos has already fully paid for this upcoming shipment, products are ready at your warehouse. SD already received the money of a part of this shipment as well.

To solve the problem of this first coming up shipment, we can prompt pay [REDACTED] 5.1.2e
We are discussing with the government to grant a new order this week already to help to solve the situation with the guarantee of our government to have a second order of another 1 mio Ag tests with approx. 50-70% payment upfront and 50-30% after receiving the goods in The Netherlands.
We hope that this is enough for SD to release the goods. We then must work out a further payment-guarantee schedule for next orders from the Dutch tender.

Then saved we can work further and pay off the existing part with the pending business.

Please let us know asap if SD Biosensor wants to cooperate with this solution.

To arrange a bank guarantee will cost us to much time and is will not be successful. The commercial value of the company is enough but this is no basis for banks. They use only fixed assets and that is not enough.

When the order will not be sent by SD, our government and one major customer wants [REDACTED] 5.1.2b back and will start a penalty for not delivering the tests to them. Secondly, we will lose the 4 [REDACTED] 5.1.2b booked and paid freight costs. The order and follow possible orders will be cancelled at SD, while if we arrange a solution together on the current order.

There still is a good possibility to achieve 1 or even more orders.
