- UK: We would like to inform you that a SARS-CoV-2 variant has been identified through viral genomic sequencing in the United Kingdom, including in 1108 individuals in England (as of 13/12/2020). Although we are currently assessing the significance of this variant, we are providing an early alert due to its spike mutations and rapid spread. This variant is referred to in the United Kingdom as SARS-COV-2 VUI 2020

 On 25 November 2020, WHO was notified by the Swedish IHR NFP that the clinical microbiology laboratory at Karolinska University Hospital in Stockholm, Sweden, had discovered poor performance of two lots of sample collection kits from Beaver Biomedicals.

 The product in question is "Sample Collection Kit", product number 43903, from Beaver Biomedicals Engineering Co, Suzhou Industrial Park, China. Affected lot numbers are 20T148403B and 20T148263B.

_

The problem was identified because the proportion of positive samples started to deviate from expected numbers gradually during three weeks, coinciding with the arrival and distribution of a new shipment of sampling tubes to a number of testing units. Laboratory experiments using a number of different assay systems confirmed a loss of sensitivity corresponding to 5-10 PCR cycles for samples diluted in the transport medium of tubes corresponding to two lots of sample collection kits. It was also observed that a subset of the tubes developed a cloudy precipitation with time.

Approximately 25 000 defective collection tubes were used. The medical consequences are
estimated to be 1000-1500 false negative test results, primarily in samples with viral loads
corresponding to Ct 25 or higher. A report has been filed to the Swedish Medical Product
Agency and the manufacturer.
