The process was initiated by our usual Dutch legal advisers, 5.1.2e who instructed Deloitte to carry out the investigation in consultation with our Internal Audit department on the grounds that i) Deloitte have expertise in analysing emails and ledgers to detect the sorts of transactions we were trying to identify, ii) my colleagues in Internal Audit were not able to travel due to Covid-19 restrictions and iii) it was felt more pertinent to have Dutch speakers carry out interviews with key members of staff. Our Internal Audit department remained involved with Deloitte throughout the process.

Before the Report can be shared with you, however, Deloitte require signature of a release letter – please see attached. Once you return to me a signed copy of this letter, the Report will be sent to you.

I hereby refer to your letter dated October 15, 2020 which was sent to LCH regarding commission arrangements.

First of all I like to emphasize that we appreciate the fact that Bunzl decided to take its responsibility to eliminate any perception of inappropriate dealings on your part.

Nevertheless, we are obliged to ask you and as far as necessary urge you to send us evidence of the statement that the commissions were cancelled and in no event led to payments being made to Bunzl or its subsidiaries. Until Bunzl can provide us with the evidence that there were no commission arrangements in the present case and there have not been similar arrangements that affected the position of the Ministry of Health, Welfare and Sport we cannot close this case. We have to explicitly exclude that these modus operandi have not also been concluded with other deals and want to determine that the Ministry has not suffered any form of damage.

Since there is a possible unlawful and possibly fraudulent act we would appreciate receiving:

• the report from your Internal Audit department that investigated this matter;

• an overview of all transactions between Bunzl and/or its companies (D-Care, King etc.) and the Ministry of Healthcare, Welfare and Sport/Mediq/LCH related to the jointly purchase of personal protection equipment related to the COVID-19 pandemic;

It goes without saying that you are most welcome to add other documents to proof your statement that the commissions were cancelled.

Once we have received the requested documents we will further investigate this matter. If you have any questions regarding this matter, please do not hesitate to contact me.
