### ADDENDUM TO CONTRACT BETWEEN THE STATE OF THE NETHERLANDS AND SYNLAB.

The undersigned:

 The State of the Netherlands, which has its seat in The Hague, represented by the Minister of Health, Welfare and Sport, Directorate-General for Public Health, legally represented in this matter by 5.1.2e
 5.1.2e hereinafter referred to as the "Minister",

and

The private limited company SYNLAB Belgium SRL, which has its registered office at Avenue Alexander Fleming 3, BE-6220 Heppignies, Belgium, registered with company registration number 0453111546, legally represented in this matter by 5.1.2e hereinafter referred to as "Contractor",

Each party also referred to as "Party", and both parties together as "Parties",

### WHEREAS:

- Parties have signed the agreement for the provision of logistical and diagnostic services with regard to COVID-19 PCR RT tests for the period September 11, 2020 to April 30, 2021, hereinafter "the Contract";
- b. The parties establish and, if necessary, agree that the Contract is in force and legally valid at the time of signing this addendum, hereinafter: the Addendum;
- c. the Contract has a term until April 30, 2021, on which date the Contract will end by operation of law unless an extension is made;
- d. the Minister has issued a guarantee under the terms and conditions stated in the agreement in the event that the actual volume ("Real Volume") per day is lower than the Guaranteed Volume per day. In that case, the Contractor may charge the price for the Real Volume as well as the price

for the difference in volume between the Real Volume and Guaranteed Volume;

- e. There is currently still an urgent need for logistical and diagnostic services related to performing Covid-19 PCR RT tests due to the persistence of the Covid-19 crisis and the potential risk of a third wave associated with several emerging variants of the Covid-19 virus;
- f. it has therefore proved necessary to extend the agreement and to adjust a number of points in the context of the transition period;
- g. the first adjustment concerns the extension of the term;
- h. the second adjustment concerns the adjustment of the Guaranteed Volume in the period of extension included in Appendix A "Schedule 1 (Services, Laboratories, Volumes and Price)" under point 6 "Volumes of Services (tests per day)";
- the third adjustment concerns the adjustment of the price in the period of extension as included in Appendix A "Schedule 1 (Services, Laboratories, Volumes and Price)" under point 7 "Pricing table";
- j. the fourth adjustment concerns the level of Safety stock
- k. Parties wish to record the above amendments in this Addendum:

### AGREE TO THE FOLLOWING:

#### 1. General

Effective 1 May, 2021, this Addendum will form an integral part of the Contract between the Parties. Capitalized words (in English or Dutch) in this Addendum have the same meaning as given to those words in the Contract.

### 2. Amendment to Article 2.1 of the Contract

#### Article 2.1 of the Contract runs until 30 April 2021:

### Formation and duration of the Contract

The Contract will run (with retroactive effect) from the 11th of September 2020 until 30th April 2021 and will then automatically expire without any notice being required, unless it is extended by mutual written agreement. The Minister may decide on any such extension in his sole discretion and will not be under any obligation to agree to an extension.
