

Appendix C should include information on measures taken to ensure that only authorized personnel will have access to the data (e.g. UMCU general measures, and password protected files), and to ensure that data cannot be stolen or stored somewhere else, whether and how back-ups are made, that RIVM will be informed in case a breach occurs, etc.

Clause 3.9 does not mean that the data cannot be published with the paper, but that RIVM is informed about what will be published and consents to it. It's an extra check.
Hope this is clear.
