Dear Colleagues

Please find attached the draft agenda and a PowerPoint presentation that outlines the structure and content of ECDC's next Rapid Risk Assessment on COVID-19. This is the background document for our discussions in Monday's extraordinary meeting of the Advisory Forum.

In addition, I attach a copy of ECDC's surveillance strategy, which was also circulated prior to the previous extraordinary meeting of the Advisory Forum. With regards to this document, please note that in our discussion on Monday we should focus on scenario 2-4 and in particular on the need to ensure that primary care and secondary care surveillance systems continue to report cases of ARI/ILI and SARI, testing a systematic number of them, in order to derive incidence data and to monitor trends. We are working on a simplified version of the strategy with a focus on the current epidemiologic situation of widespread transmission in all countries, which will be disseminated later, but the key points in that will not differ from the attached document.
