Depending on the complexity and the volume of the airlift / logistical support services required we can either work on ad-hoc basis and/or on basis of a framework agreement.

Crucial during emergency situations of this nature is the ability of the Tasking/Contracting Agency to take immediate decisions and sign tasking orders and/or charter agreements without delay as the airlift capacity and associated pricing on the current market is changing from minute to minute. In addition to the aircraft & crew availability we will need all time available to organize the traffic rights and associated logistics. We provide 30 days (from the date of invoice) credit to the Netherlands Government for the charter and associated costs.

Through our network of worldwide offices we can provide assistance in customs clearance and delivery.

As soon as we receive a formal request to proceed we will immediately check the availability on the spot market and provide you with a quotation. It is important to note that quotations are subject to aircraft and crew availability at the moment of booking / written confirmation by the Tasking/Contracting Agency.

We need to have a list of authorized persons who are entitled to act and provide us with instructions on behalf of the Tasking/Contracting Agency.

For your reference I am attaching a copy of our standard charter agreement as well as our General Terms and Conditions.
