Subject: Written Procedure: Second Amendment of the ECDC Single Programming Document 2021-2023

Dear Members of the Management Board,

On behalf of 5.1.2e 5.1.2e ECDC, enclosed herewith for your approval, please find attached the amended "Single Programming Document (SPD) 2021-2023".

The SPD 2021-2023 was originally approved during the 50th Management Board meeting in November 2020, and amended in March 2021 following your approval. The present amendment of the document incorporates the additional enhanced genomic-based surveillance activities discussed at the Extraordinary Management Board meeting of 07 May 2021, and the resources that ECDC will receive to implement them.

The changes compared to the previous version of the SPD 2021-2023 (all highlighted in yellow in the document, for easier reference) are:

1. Inclusion of the public health microbiology support programme focused on rapid detection of SARS-CoV-2 variants, for which additional resources from a second amended EU budget 2021 have already been assigned to ECDC:
 - * Direct support to Member States through providing outsourced sequencing of Member States isolates, for enhanced monitoring of emerging and known SARS-CoV-2 variants;
 - * Implementation of whole genome sequencing (WGS) and Reverse Transcription Polymerase Chain Reaction (RT-PCR) infrastructure and capacity-building in Member States.
2. Update of the budget and human resources-related information throughout the text of the document;
3. Update of the resource allocation per action area of the ECDC strategy 2021-2027;
4. Update of the following annexes:
 - * Annex 1. Organisation chart 2021
 - * Annex 2. Resource allocation per activity
 - * Annex 3. Financial Resources
 - * Annex 4. Human Resources (quantitative)
 - * Annex 10. Strategy for the organisational management and internal control systems
 - * Annex 11. Financing Decision (procurements) 2021
 - * Annex 12. Plan for grant, contribution or service-level agreement

Please note that at this stage the suggested de-prioritisation of the current work plan would not require a change in the FD, as we are still planning to do as much as possible of the work albeit a bit later in the year.

You are kindly invited to approve this written procedure by Tuesday, 1 June 2021, 14:00 CEST. In the event that we do not receive a response from you by the aforementioned deadline, your agreement thereto shall be assumed. The approval of this item in this written procedure is a pre-requisite for ECDC to initiate the implementation of the granted additional budget and positions.
