Dear Colleagues,

As an update, the 1.5 million KN95 GB26262006 masks, which have been distributed are not appropriate for use. These masks have been tested in four Member States and the results are negative.

We are in the process of arranging details to recall the products from receiving countries. Please therefore continue to refrain from using these masks and in due course they will be picked up.

Going forward, we are working to ensure an adequate resolution to this quality issue, which will also entail, prior to future distributions, that a quality control test of the actual batch is run in the EU. We will keep you informed of future scheduling as soon as possible.

We take this opportunity to apologize for any inconvenience caused, to reiterate the absolute priority for quality and safety of personal protective equipment and to thank countries for the feedback they have provided so far.
