I have taken note of the response from LCH that they will not proceed on the offered alternatives.

You have indicated that you do not wish to take delivery of the 3M-1860 face masks which are now ready to be shipped and wish to cancel the sales agreement which has a total value of Euro [REDACTED]. I will need to provide an answer to the suppliers tomorrow and therefore we will need to find a settlement.

Based on our existing commitments to suppliers and the brokers involved in the sourcing of the 1860s, we will need to charge you a cancellation fee to cover these as well as our own costs incurred. While it is standard (and in our standard terms and conditions on the web site to charge 10% cancellation) we have calculated that our obligations in terms of cancelling your delivery should be limited to 2,6% , if we can cancel tomorrow and if we are able to reach agreement with the brokers.

I look forward to your response and will be available for a meeting at your earliest convenience.
