The parties are aware of and agree with that the goods on this special order items contract are bought in a volatile market, which because of the current and worldwide Corona situation is a rapidly developing market, including changes in available quantities, prices etc.

This means that there may be discrepancies in the quantities on the orders. Abena is not responsible towards the customer concerning quantity and security of the supply. If Abena is unable to deliver the goods in whole or in parts under this agreement, no claims can be raised, neither direct or indirect claims can be made.

Price adjustments may occur in connection with raw material or exchange rate changes, changes in shipping prices can occur, in relation to delivery barriers or other external changes such as tax changes.

The customer is obliged to buy the agreed quantity from Abena, but not eligible to purchase quantities besides what is agreed upon, unless a separate agreement is entered regarding this.

Abena thus makes reservations for unforeseen delivery barriers. Abena reserves the right to cancel or suspend the order if Abena or its subcontractors are to be prevented from fulfilling the contract as a result of a government intervention or other matters caused by the current COVID-19 pandemic. The parties agree that none of the parties may make any claim against the other part should this clause be activated.

The contract only covers the purchase of this item.

The parties agree that neither party can make any claim against the other party in the event that Abena cancels or suspends the order.

The product is covered by applicable parts of SS-EN-166 and related standards SS-EN-167 and SS-EN-168, but does not fulfill these standards. The product has not been tested or approved by officially recognized certification authorities.

Abena does not issue a CE-mark, and it is buyer's responsibility to ensure and obtain permission from the authorities to use the product. The customer carries the risk for this himself.

The customer cannot claim any warranty on the product and cannot return goods, either in terms of quality or quantity. If the customer has ordered larger quantities than can be used, the customer himself carries the risk hereof.

The contract is independent from all other contractual obligations the customer and Abena may have.
