This morning you have spoken to my colleague 5.1.2e from the Dutch Ministry of Health about the EU contribution for cargo costs under the Emergency Support Instrument. The Netherlands has applied for the ESI Mobility Package and has signed a Grant Agreement for this with the European Commission.

As my colleague has informed you this morning, we are not able to meet the set timeline for handing in all the necessary documentation that has been requested by DG Echo for the ESI Mobility Package. Due to the COVID-crisis and the extensive extra purchases and workload for the Ministry our financial advisors have not had sufficient time to handle the request.

I would therefore like to kindly ask you whether it is possible to agree on a later deadline? Our financial department has informed us that – if they ought to control and collect the documents meticulously – they will need 6 months to deliver. We sincerely apologize for not being able to meet deadline.
