**Subject:** Next steps - RE: UNCOVER UNCOVERED!

Dear colleagues and friends,

Thank you for the interest many of you have expressed in resubmitting an updated version of the UNCOVER application to the '[Cohorts united against COVID-19 variants of concern' call](#)'. The deadline for this call is soon, on May 6 at 5pm CET.

In preparation of the resubmission, we have done the attached gap analyses, comparing the original UNCOVER application with what is asked for in the current call. We concluded that the new proposal should shift its focus to enable real-time monitoring and characterisation of (emerging) **SARS CoV-19 variants of concern** including responses to various vaccines and vaccination schemes. We also need to include a much stronger focus on impact.

To meet these requirements, we will have to restructure, reprioritise, and rewrite the original WPs. Some WPs may have become redundant under the current call, which could result in fewer consortium members. The budget available for the current call is 7 to 10 million euro, which is significantly less than the original 20 million. Budget changes are therefore also inevitable, including a shorter duration of the project.

We have scheduled a consortium meeting on **Monday April 26 at 3-5pm CET** to discuss the resubmission further. The meeting invite will be sent shortly.

**For now, could you please indicate, as soon as possible, whether information on SARS CoV-19 variants is currently, or will become, available for which of your cohorts?** We will prepare and circulate a proposal for the necessary changes and new WP structure based on this. We will also circulate a list with more detailed questions by the end of week that will help to refocus and triage for further discussions around the structure and content of the proposal.
