Request for information regarding an EU-wide coordinated effort concerning post COVID-19

Dear Commissioners

In the European Union, people from all Member States, in a wide range of ages and from diverse backgrounds, are being affected by post COVID-19. The World Health Organization defines this condition, which is commonly known as long COVID, as the continuation or development of new symptoms three months after the initial SARS-CoV-2 infection, with these symptoms lasting for at least two months with no other explanation.

On the 9th of December 2022, in the framework of the Employment, Social Policy, Health and Consumer Affairs Council (EPSCO), I discussed the importance of doing even more with the European Commission and other Member States. The Netherlands called for a comprehensive and collaborative EU-wide effort to develop and support the post COVID-19 research agenda and to facilitate the exchange of best practices among clinical centers and practitioners. There was broad support from Member States for this call. Coordinated research will facilitate effective insight in common priority issues and improve validity of results. A coordinated EU-wide effort should highlight existing knowledge gaps and help streamline research. An effort to facilitate exchange of best practices among experts and health practitioners can help to provide the best possible care to people with post COVID-19 symptoms. I am convinced we should approach this at an EU level instead of working parallel on national levels.

I am very impressed with the work of DG SANTE and DG RTD regarding post COVID-19 so far, setting up specific research projects under Horizon Europe and organizing meetings to bring experts together, both within and outside the EU.

Besides, The Netherlands is drawing up a research agenda which, with regard to biomedical and clinical research, can serve as input to coordinate post COVID-19 research in the EU.

I look forward to making even more progress in this field with both of you and would be more than willing to look into jointly addressing the coordinated response in the next EPSCO Council meeting on Health on the 14th of March 2023.
