Dear colleague,

In the Netherlands, we do not advice the general public to wear face masks for the following reasons:

- As the ECDC study shows, there is little evidence that this is an effective intervention for source control
- it might lead to further spread by frequently face touching
- it might lead to decreased adherence of other control measures such as social distancing
- there is shortage of masks

We strongly advice to adjust the conclusion in the guidance document, that there is little evidence of effectivity of this intervention, that implementation should be very carefully considered as it might have negative side effect and other control measures are far more effective.
