We hope to send the first surveys out next week, using Ipsos.

5.1.2e are checking the translations and making further adjustments for Flemish, but would you (or a colleague at RIVM) be able to have a quick read through the NL-Dutch version as well? I've attached both the NL-Dutch and English version. It may be good to double check whether we capture all social distancing interventions which are planned in the Netherlands as well.

Also, we submitted for fast-track ethics at LSHTM last week, and hope to get ethics approval very soon. Do we require additional ethics approval in the Netherlands? We're double checking this in Belgium as well.
