Dear 5.1.2e

In response to our phone call this afternoon we emphasize that we keep to the same agreements as originally agreed. Nedshield will transport the masks to the Netherlands and the Ministry of Health will pay after delivery and a quality check of the products.

We anticipate to take a sample of the masks from more than one package and to test the quality in one of the hospital labs. The quality check will consist of a visual inspection and a control on the number of filter layers in the mask. In addition, a quantitative test of the mask will be done on 3 parameters. 1) test of the permeability of the material (should be >94% for ffp2 level); 2) a splash test; and a face fit-test. If the masks pass these test parameters, the masks will be accepted and the government is able to pay (of course depending on the volume (number of masks delivered)). This quality check will take at least 4-6 hours depending on the speed of transport and the capacity in the lab.

Please specify your Escrow method of payment in detail so the Dutch Ministry of Health can assess whether we can work with this method. If not, the Dutch Ministry is able to arrange a fast payment process.

5.1.2e updated me on the call 5.1.2e As he mentioned to you we have managed to secure the 5.5m of the original type ordered and will be able to deliver these and so as requested, we have updated contract, for good order, to reflect the original Face mask type 1860.

Update :

The 8210V type are still held up with the export controls in the US. Our suppliers still have the charter flight booked for 5 April – but no update has been given yet (was supposed to have been issued last Friday).

Given the developing shortages in the US, we are not taking a chance and so have secured the 1860's – I am currently getting the dates for the delivery set-up, and should have these during the course of tomorrow- given the time differences.

In the case that the 8210v are actually released we will have then the possibility to discuss whether this could be taken – or we will be able to offer this through to the German Health Ministry, with whom we were in contact today.

We will be in contact tomorrow in regard to the financial arrangements to secure this (which will we expect involve 3M company directly to secure the mask certification).
