Thanks and appreciate your reply despite you're extremely busy just of Ministry of Health and Welfare in Korea does. Daily COVID19 media briefing, distributing PPE on each every sites in the country. I can imagine how much you and entire government are busy fighting against COVID19.

As you mentioned about your concern below, I would like to inform you of it.

1. KN95 masks / [REDACTED] 5.1.1c pcs shipment: Completed and last shipment has arrived at Amsterdam on Apr, 8th, 14:20

In case you need to take some sample for testing, I have added some extra masks in the packing.

2. Cause of various masks in the shipment

As Dutch gov urgently needed KN94 masks ASAP, I had to intercept some of masks, which will goes to Iran from the factories. But I didn't want to negotiate with quality and price. I was able to ship out ASAP.

In order to secure the allocation of mask and shipment, I has to hire guards to monitor factories and make sure our masks should not be sold to other buyers, who brings the cash in the bag.

3. Same design and manufacturer for future orders.

I will supply KN95 mask from same design and packing for future order.

Again I do appreciate a support from Dutch government Shanghai consulate .

It was helpful to reserve the airline cargo space despite it was large shipments.

4. PPE supply in expressway.

Due to expansion of high demand of PPE from the rest of world, USA, South America, South Africa, India, Japan, Indonesia,

There are big shortage in masks, gloves, medical suits. If you send a PO, it will be much helpful to reserve the mask with manufacturers. Due to increasing demand of KN95 worldwide, I anticipate serious shortage will continue.

Thanks to [REDACTED] 5.1.2e I am very proud to serve Dutch government.

Thank you for your information in this email and the efforts you have made.

Although the order you mention was originally done by Dutch Hospitals (not by the government), we as a ministry will act to make sure this volume of masks is cleared at Schiphol Airport and transported to the right locations. I do not have a complete picture of the testing results of the masks but I got the feedback that in these shipments consisted of various types of KN95 masks.

As you may have heard, the procurement of Personal Protective Equipment has been centralized in a National Consortium in the Netherlands. So any future lead will be handled by this consortium. Nevertheless, I would like to thank you for your offer to assist and will inform the consortium accordingly.
